Vienna, 21 October 2019 Publicly listed construction group STRABAG SE has won the first prize of the Austrian Financial Communication Award in the ATX Prime segment. The assessment is carried out by the Chair of Accounting and Auditing at the HHL Leipzig Graduate School of Management under the direction of Prof. Dr. Henning Zülch and the Hamburg-based consulting firm Kirchhoff Consult. Based on the RIC model developed in Leipzig, the quality of the financial communication is measured in the fields of “Reporting”, “Investor Relations” and “Capital Markets”.
